

Getting the most out of AvaTax begins with implementation. Avalara offers support to get you up and running for as long as you're using AvaTax.





Set up AvaTax

Setting up AvaTax is a four-step process:

- **Gather information about your business.** To create your company profile, you'll need to have certain information on hand, such as your employer identification number (EIN) and international tax identification number if you do business outside the U.S. You'll also need the information described in the following steps. In addition, you'll need the names and email addresses for others who will have access to your account.
- **Use the AvaTax setup wizard to create your account.** We'll ask you where you do business, including locations where you have a physical presence, remote employees, and ecommerce sales. You'll also tell us where you're already registered to collect tax.
- **3 Connect AvaTax to business systems you use to process or store orders.** To do this, you'll need access to your business system account, and you may need administrative privileges.
- Fine-tune your tax profile. In this step, you'll provide information about the products you sell, including assigning tax codes and Harmonized System (HS) codes for international sales. You'll also provide information about your tax-exempt customers. Fine-tuning your settings helps AvaTax calculate the best tax rate.



Determine whether you may be out of compliance

AvaTax shows you what you need to do to stay compliant. When you sign in to the AvaTax portal, your homepage will show an interactive economic nexus map. AvaTax tracks your company's sales in the U.S. and alerts you to where you may be close to meeting a state economic nexus threshold, and therefore where your company should consider registering to collect and remit sales and use tax.

Follow rate changes for every address

There are more than 13,000 U.S. sales and use tax jurisdictions, each with its own rates and rules.

AvaTax uses geospatial rate targeting to help ensure you calculate and collect the right tax.

The solution verifies purchase addresses and assigns street-level tax rates, rather than relying on ZIP codes. Geolocation technology calculates more accurate taxes for transactions occurring on mobile devices as well as ecommerce, POS, and ERP platforms. Simply select a transaction in AvaTax to find out the tax rate and where the item was shipped.

Farhad is the controller for an online retailer specializing in pet supplies. His company recently expanded into Colorado. Colorado is a home rule state with 272 municipalities; cities, counties, and special taxing jurisdictions administer and establish their own sales tax rates and rules. With AvaTax, Farhad can calculate sales and use tax more accurately using geolocation technology that pinpoints addresses and applies the right rates.

Keep up with taxability changes

Create business reports

AvaTax helps your team be organized and audit-ready with robust reporting features. Create and export reports that help you reconcile your transaction data each month, decide tax liabilities, and identify exemption exposures. Review information for multiple tax types and cross-border sales. Customize reports to provide more information and apply filters to see line-item details.

Review and reconcile marketplace transactions

Marketplaces where you sell your products, such as Amazon or Etsy, may be required to collect and pay tax on your company's behalf. Some jurisdictions require you to report (but not pay) tax on all sales even if a marketplace has paid the tax for you.

AvaTax allows you to view details about your marketplace sales and determine whether tax on a transaction needs to be paid when you file your return.



HOW AVATAX CAN HELP

Drew is the ecommerce product manager of a company that manufactures running shoes. Their business sells products on several marketplaces as well as their company website. Drew needs a tax compliance solution that can track whether or not a marketplace has collected tax for a transaction. Drew uses AvaTax to track sales and help ensure they remit the right amount of sales and use tax in each state.

Calculate international taxes and customs duties

<u>Avalara AvaTax Cross-Border</u> minimizes surprises for customers by calculating or estimating customs duties upfront and populating international taxes into online shopping carts.

To calculate customs duties, VAT, GST, or other local taxes, you'll need to tell us where you're selling. Your portal includes a section for customs duties and another for VAT and GST. In most cases, you should add your locations to both.

When selling internationally, you need country-specific Harmonized System (HS) codes, also called tariff codes, for all of your products. **Avalara Tariff Code Classification** combines AI and human expertise to quickly provide tariff codes for products going to 180+ countries. You can also include the full HS code on your invoice to help your products pass through customs without delays.

To include duties and taxes in the transaction, you need to ship Delivered Duty Paid (DDP). This means you're responsible for paying the customs duty and import taxes. If you ship DDP, you need to tell us you're the importer of record. If you choose to ship Delivered at Place (DAP) instead, your product will be held at customs until your buyer pays the customs duty.

AvaTax Cross-Border integrates with Avalara Tariff Code Classification and <u>Avalara VAT</u> **Reporting** to provide end-to-end global tax compliance in a single platform.
