

An exemption certificate is the form presented by an exempt organization or individual to the seller when making a taxexempt purchase.





#### REASON 1: Lack of awareness

" Most of my sales are exempt, so I don't have to worry about sales tax..."

Exemption certificate management isn't about collecting tax but proving why you didn't. Sales tax may need to be collected as you move to sell directly to end users



#### REASON 2:

#### Customer management

- Customers feel burdened by providing accurate documentation on time
- It's presented as a billing issue because charges aren't done correctly
- Front-line employees need a smooth collection process to earn customer trust
